Statistics Canada confirmed Canadians are feeling less knowledgeable about finances than before. Upon graduation, many Canadians feel they are not equipped with enough knowledge to navigate their finances successfully. In addition, a growing number of young adults admit that social media is their primary source for financial advice and information.

Please address all 3 of the following questions in your video:

- 4 How can you expand your financial literacy knowledge and skills?
- What are some savvy financial tips and strategies that can help you become financially stable and successful?
- What are the risks of relying on social media influencers for financial guidance and what advice or recommendations would you share to avoid serious financial harm?

Criteria:

- ✓ Contain only copyright-free content
- ✓ Video length must be between 60-90 seconds
- ✓ English or French only
- ✓ Use one of the following video formats: MP4, AVI, MOV or WMV

Recommendations:

- ✓ Have a creative, catchy title that reflects your ideas, followed by your full name.
- ✓ Review your video and edit for sound quality. (volume, background noise, etc.)
- ✓ Consider your background setting for optimal viewing.
- ✓ Be original, creative, inspirational, and authentic.

John Eisner Financial Literacy Scholarship 2025-2026 Rules and Regulations

Credit Counselling Services of Atlantic Canada, Inc. (CCSAC), operating as SolveYourDebts.com, is holding a scholarship competition open to residents of Atlantic Canada (regardless of age) who will be enrolled in an accredited post-secondary program for the 2025-2026 academic year.

Applications are accepted in both English and French. There are several scholarships available.

- 1. The applicant must intend to enroll in an accredited institution for the 2025-2026 academic year. Only the winning applicants will be required to provide proof of acceptance, as well as proof of enrolment for both Fall 2025 and Winter 2026 semesters.
- 2. Submissions must include a completed application entry form (online) and a 60-90 second video link. Videos must meet all criteria outlined in the above application. Submissions must be the applicant's original work and contain copyright-free content.
- 3. Videos **MUST NOT** include any names of other individuals, schools, businesses, or locations. It is acceptable to reference their title, relation, or type of business/organization (e.g., teacher, parent, uncle, school, bank, etc.).
- 4. Upload your video to <u>YouTube</u> or <u>Vimeo</u>. **No video should be set to public access before the contest and any share options must be set to "Give access to anyone with the link."** Please ensure your link address is correct before copying to your application form. Videos must be accessible for viewing without login or passcode required.
- 5. Winning applicants and possibly other honorable mentions will be required to provide a copy of their original video through a file sharing platform. Further instructions will be communicated to applicable applicants after the judging process has been completed.
- 6. Application entry form including a video link must be submitted through SolveYourDebts.com online Scholarship Application Entry form. **Submissions must be received no later than 11:59** pm AST on May 4, 2025. Video links must remain active and accessible until July 31st, 2025, for judging purposes.
- 7. Employees and board members of SolveYourDebts.com and their families are not eligible for this contest.

Only submissions that conform to the rules and guidelines will be considered. Submissions cannot be returned and may be posted on the SolveYourDebts.com website, social media accounts, and/or used for other promotional or educational purposes. Winners will be notified by the end of June 2025 and scholarship funds will be disbursed by January 31, 2026. No materials other than those required for the submission and application form are to be submitted. Judges' decisions are final.
